The Board will discuss and may vote to take action on the following matters:

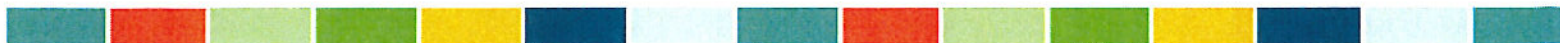
