5. Approval of the VSIG, VSWCG, VSEBG, and VSMG financial statements for the months of December 2020 and January 2021 - Dan Davison.

VSIG - Dan Davison reviewed the Valley Schools Insurance Group financial statements in detail. He pointed out the consulting services fees were overbudget due to Cash, Sullivan, and Cross ("CSC") special services provided. Tom Boone added consultant fees are prepaid. He also stated change in market values are negative and depending on rates, book values go up and down. Valley Schools goal is to hold to maturity.

VSWCG - Dan Davison reviewed the Valley Schools Workers' Compensation Group financial statements in detail. He added most of the subrogation/restitution is from one member.

VSEBG - Dan Davison reviewed the Valley Schools Employee Benefits Group financial statements in detail, noting the largest asset is Morgan Stanley and largest liability is prepaid contributions.

VSMG - Dan Davison reviewed the Valley Schools Management Group financial statements in detail, noting the office expenses are high because there was a retroactive rental payment.

6. Review Valley Schools Insurance Group/Valley Schools Workers' Compensation Group Annual Report, June 30, 2020- Tom Elliott.

A hard copy of the Valley Schools Insurance Group/Valley Schools Workers' Compensation Group Annual Report, year-end June 30,2020 was provided to the Board.

Tom Elliott reviewed the report and discussed claims increases/decreases, excess premiums/coverages, loss ratio and total assets. Short discussion took place.

# 7. Executive Director Member Services update - Tom Elliott.

Tom Elliott reviewed the medical and dental plan summary report for all members. He pointed out Valley Schools members are currently running better than last year, and the dental pool is also doing well. Discussion took place about specific members. He indicated we have a new vision carrier in addition to UHC vision. Renewals are almost complete and those not yet finalized are currently in the members hands. Open enrollment planning has happened, and most members are opting for virtual open enrollment meetings instead of in person. We are in the 5<sup>th</sup> year of zero increase in dental rates.

#### 8. Marketing/Sales update - Sheri Gilbert.

Sheri Gilbert provided a marketing and sales update to the Board. She highlighted several key items. Conversation took place about competitors and contracting was discussed, noting Blue Cross/Blue Shield is no longer servicing Kairos members. The Marketing/Sales department has added some team members who will specifically focus on new business. A discussion took place pertaining to several vendors. Jim DiCello asked questions about competitors and Sheri Gilbert replied. Mike Barragan asked questions regarding new business prospects and discussion took place.

### 9. Wellness Services update - Kendall Taylor.

Kendall Taylor provided an update on what is going on in the Valley Schools Wellness Department. She discussed several programs currently being looked at and vetted for our members. We have moved forward with an expansion of mental health services through UHC, both inpatient and outpatient. This will be offered to our members beginning July 1, 2021. Opioid management is also included. Jim Migliorino asked about a specific stress management platform Deer Valley Unified School District is using thru UHC and a short discussion took place.

### 10. Chairman/CEO summary report and update— Tom Boone.

Tom Boone reviewed the details of the next meeting VSMG Board meeting, spoke about the Sage Financial Services Conference scheduled for March 24, 2021 and discussed overall administrative costs.

#### 11. Board Member comments.

Laura Felten expressed her thanks to the Board Members for their support while she served on the VSMG Board. Tom Boone, Jim DiCello and Mike Barragan thanked Ms. Felten for her service and acknowledged all she has done for Valley Schools as a Board Member.
