4. Legislative Update - Meghaen Dell'Artino/Gretchen Jacobs.

Meghaen Dell'Artino provided a legislative update. She reviewed education-related bills going through the legislature and provided the board with information on issues that would affect schools. She also provided a briefing about the situation on water-related matters being debated in the House and the Senate. Scott Butler expanded upon the information shared by Meghaen Dell'Artino and provided some additional information, noting this has been an odd legislative session.

Various political races were also discussed, and conversation took place.

Tom Boone turned the meeting over to Vice-Chairman Jim DiCello.

5. Approval of the Valley Schools Insurance Group ("VSIG"), Valley Schools Workers' Compensation Group ("VSWCG"), Valley Schools Employee Benefits Group ("VSEBG"), and Valley Schools Management Group ("VSMG") financial statement for the month of April 2022 – Laura Felten.

<u>VSIG</u> – Laura Felten reviewed the VSIG financial statements in detail. Most of the changes were the typical monthly expenses; however, she noted market value changes. Valley Schools investments are held to maturity.

<u>VSWCG</u> – Laura Felten reviewed the VSWCG financial statements in detail. Most assets are with Morgan Stanley, and the largest liability is in paid claims. Industrial commission fees have been paid for most of the year, which is reflected in the financial statements. Change in market value was noted.

<u>VSEBG</u> – Laura Felten reviewed the VSEBG financial statements in detail.

<u>VSMG</u> – Laura Felten reviewed the VSMG financial statements in detail. The majority of assets are in investments. The marketing budget has been recorded in the VSMG financial statements.

6. Review/approve proposed budgets for FY 2022-2023 - Laura Felten.

<u>VSIG</u> – Laura Felten reviewed the Valley Schools Insurance Group proposed budget in detail. Contributions have increased from last year. Some strategic conversation took place on the Property & Liability premiums. Increases will be phased in over the next two years. She noted that the value of our property has increased, affecting the P & L premiums. Liability coverage has also increased. Estimates on additional layers of the Liability coverage were reviewed. Mike Barragan asked if we do not require these values to be updated annually, and Laura Felten explained. Other discussions took place. Tom Elliott provided some additional information about the P & L coverages. A discussion took place.

<u>VSWCG</u> – Laura Felten reviewed the Valley Schools Workers' Compensation Group proposed budget in detail. Jim Migliorino asked about the claims paid liability increase, and Laura Felten responded.

<u>VSEBG</u> – Laura Felten reviewed the Valley Schools Employee Benefits Group proposed budget in detail. Laura noted this budget is mainly dictated by the benefits elections our members choose. Contributions are what we bill our members and what is reported in the internal services fund. Changes to membership are reflected in this budget. She noted we have an internal stop loss program and explained further. She stated the Wellness budget has changed this year. VSEBG and Wellness have been split on the budget instead of being combined.

<u>VSMG</u> – Laura Felten reviewed the Valley Schools Management Group proposed budget in detail. The most significant portion of this budget is salary and benefits. A few changes have occurred since the original proposed budget was brought to the Board in April. Jim Migliorino asked about the salary and benefits line, and a short discussion took place.
