MINUTES OF THE MEETING OF MAY 27, 2020

The meeting was called to order by Tom Boone, Chairman, at 11:57 a.m. 1.

Approval of the Valley Schools Insurance Group ("VSIG"), Valley Schools Workers' 4. Compensation Group ("VSWCG"), Valley Schools Employee Benefits Group ("VSEBG"), and Valley Schools Management Group ("VSMG") financial statements for the month of April 2020 - Dan Davison.

<u>VSIG</u> – Dan Davison reviewed the Valley Schools Insurance Group financial statements in detail.

<u>VSWCG</u> – Dan Davison reviewed the Valley Schools Workers' Compensation Group financial statements in detail, stating the largest asset is the investment at Morgan Stanley and noting the positive change in market value. Bill Maas asked how much actual money is in the fund and Dan Davison said most of what is on the financial statements is unrealized and provided further explanation. Tom Boone added market value change is an accounting transaction, not a cash transaction. A discussion took place.

<u>VSEBG</u> – Dan Davison reviewed the Valley Schools Employee Benefits Group financial statements in detail. Jim Migliorino said the Deer Valley Unified School District is seeing claim costs go down in their loss ratios and asked if the other members were experiencing the same thing. A discussion took place.

<u>VSMG</u> – Dan Davison reviewed the Valley Schools Management Group financial statements in detail. Mike Barragan asked why the Management Group financial statement doesn't have a change in market and Dan Davison answered. Tom Boone stated the budget for the Management Group was increased. Mike Barragan inquired what the rational for not having a net position no more than 25% of total revenues and Mr. Boone answered.

5. Review/approve proposed budget for Fiscal Year 2020-21 – Tom Boone/Dan Davison

Dan Davison reviewed the proposed budgets for VSIG, VSWCG, VSEBG and VSMG in detail.

<u>VSIG</u> – Current expenses for claims were projected based upon most member districts being closed. Adjustments were discussed. Aon actuarial adjustments have come in and Mr. Davison reviewed those. Projection of interest earnings is lower for next year. Tom Boone added reinsurance cost was reduced and paid claims now reflected the actuarial study projections. A short discussion took place about the actuarial reports. Tom Elliott added the cost of reinsurance has gone up and the contributions haven't been raised for several years.

<u>VSWCG</u> – Dan Davison stated Peoria Unified School District is not increasing contribution next year. A discussion took place on contributions.

<u>VSEBG</u> – Dan Davison said stop loss has been trending favorably, so the budget was reduced based upon the trend. A discussion about stop loss took place.

<u>VSMG</u> – Dan Davison pointed out the conference travel budget has been adjusted down due to COVID-19 and the rest of the budget was reviewed.

Mike Barragan stated he has concern over a couple of members contributions levels and would like to see something in the policy that references the "managements competence and responsibility". A discussion took place.
